Subject: Revisiting of incentives/ facilities to be granted to Central Government employees for participating in national/ international sporting events –reg.

Department of Personnel & Training and Ministry of Youth Affairs & Sports are reviewing the guidelines/ instructions relating to recruitment of meritorious persons in Central Government offices against sports quota. It will review the existing policy and suggest measures for promotion of sports and sports related activities and to widen the lists of sports disciplines which qualify meritorious sports persons for appointments in the Government of India.

2. Secretary, Department of Sports vide D.O. letter dated 27.12.2016 (copy enclosed) addressed to Defence Secretary has urgently sought the information relating to sportspersons employed during the last five years as well as the details of utilization of such sportspersons and medals won by them before and after they were employed.

3. All the Administrative Wings are therefore, requested to furnish the requisite information in the proforma attached by 25.1.2017. It is also requested that concerned Administrative Wings should compile the information from all the Dte/Est./Org. under their control and send it to CP Division in a consolidated form. The names of contact details of Nodal Officers nominated for the matter may also be intimated to facilitate further coordination in this matter.

Dear Sir,

Department of Personnel & Training, Government of India has issued "consolidated instructions on incentives for sportspersons" in Government of India. In accordance with these instructions, Ministries / Departments of Government of India can recruit meritorious sportspersons upto the extent of 5 per cent of vacancies in any year in relaxation of recruitment process subject to the condition that overall reservation under all permissible categories does not exceed 50 per cent of the total number of vacancies proposed to be filled by direct recruitment. In addition, other incentives in the form of out of turn promotions, advance increments, etc., are also given to meritorious sportspersons.

2. The policy of recruitment and other incentives to meritorious sportspersons is under review. Accordingly, the information and details regarding appointment of sportspersons in your Ministry / Department including the Public Undertakings, Autonomous Body etc. functioning under the Ministry / Department during the 5 years may be furnished urgently. The details of utilization of such sportspersons and medal won by them before and after they were employed may also be provided.

3. Since this provision is meant for giving financial security to outstanding sportspersons, I shall be grateful if you could look into the matter personally and facilitate submission of the required information in the enclosed proforma at the earliest.
