SUB: Subsidies paid by Government to various companies / corporations and autonomous bodies etc from Defence Services/Civil Estimates - Report for 1999-2000 in respect of DAD and Non-DAD.

As Controllers are aware, the above mentioned report is required to be submitted to this Office by 15th of July every year to enable us to forward the same to the MOD (FIN/BUD) DGADs for incorporation in the Appropriation Account.

2. It has been our experience either the reports were not rendered on due date due to various reasons or were incomplete, resultant problem was faced in rendering complete report to MOD (FIN/BUD) and DGADs. Further, there have been instances when in response to the reminders issued by this Office, we were informed that the matter has been referred to sub-offices. This would suggest that perhaps adequate attention is not always paid by the staff to obtain information in advance from the sub-offices and furnishing the reply complete in all respect.

3. It is, therefore, requested that CsDA may kindly ensure that the reports are rendered complete in all respects by due date. It may also be ensured that the following points are covered while rendering the report.
