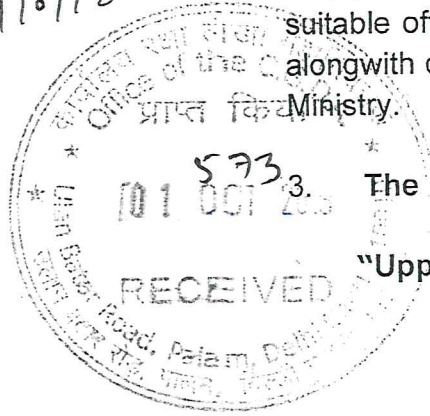
OFFICE MEMORANDUM
