Subject: Promotion of Asstt. Accounts Officers to Accounts Officer's grade against the vacancy year 2020.

32 (Thirty Two) AAOs listed in **Annexure-A** enclosed to this letter, have been approved for promotion to the grade of Accounts Officer in the Pay Level-9 of the 7th CPC Pay Matrix (Rs. 53,100 to Rs. 1,67,800). AAOs listed at **Sl. No. 01 to 24** of **Annexure-A** have been approved for promotion with immediate effect or from the date of assumption of charge to the post of Accounts Officer, whichever is later. Whereas, AAOs listed at **Sl. No. 25 to 32** of **Annexure-A** have been approved for promotion with effect from 01.04.2020 or from the date of assumption of charge to the post of Accounts Officer, whichever is later.

2. Before promotion of these AAOs to the grade of Accounts Officer, it may be ensured that none of the circumstances enumerated in para 2 of the DOP&T OM No. 22011/4/91-Estt. (A) dated 14.09.1992 have arisen. If such circumstances have arisen, the promotion shall not be released and instead considered as if the case of the officer concerned has been placed in Sealed Cover by the Departmental Promotion Committee in terms of para 7 of the said OM and an intimation to this effect be given to this HQrs Office.

3. Present office / organization shown against the names of AAOs are as per the information held in AN-II section of this HQrs Office. If an officer is under order of transfer and he / she is yet to join the new place / organization of duty, the said transfer order (in AAOs grade) may be treated as cancelled. The organization under which the promoted AAO is posted as on date, may relieve the officer to assume charge at the new place of posting.

4. In cases where the office of posting on promotion to AO's grade have not been indicated and only the station & organization have been mentioned, the AAOs after getting relieved may report and take charge in any of the offices situated at that station under the organization allocated. After taking the officer on strength and promoting him / her to the Accounts Officer's grade, the concerned organization may accommodate such officers in an office within the organization at the station shown in this promotion order. A copy of the allocation so made may be forwarded to this HQrs. Office through e-mail on hqan2.cgda@gov.in, for updating the data base.

5. Relief of the officers shall not be deferred on the ground that representations have been submitted for change of place of posting or on the ground that relievers have not been provided. It may be brought to the notice of the officers that all efforts have been made to accommodate them at the choice stations preferred, to the extent of administrative feasibility. Controllers may also ensure that representations are not unduly forwarded. Representations not routed through proper channel / directly submitted to this HQrs Office will not be attended.


6. TA and joining time as admissible under rules is authorized.
