Subject: Promotion of Steno-II to the grade of Steno-I for the vacancy year 2022.

If such circumstances have arisen, the promotion shall not be released and instead treated as "Deemed Sealed Cover" case in terms of Para 7 of the said OM. It may also please be ensured that individual is not promoted till expiry of penalty period, if he/she is undergoing the period of penalty. The promotion order notified by your office should also indicate that he/she has been selected for the promotion of the grade of Steno-I by PCDA/CDA. The promotion order should also indicate that he/she may exercise an option with in a period of one month as DP&AR OM No.1/2/97 Estt (Pay-I) dated 23.04.1999.

3. The case of refusal of promotion may be dealt with by PCDA/CDA office itself, being the appointing authority in light of provisions contained in DOP&T OM No.22034/3/81-Estt(D) dated 01.10.1981. The HQrs. office may please be informed accordingly.
