With reference to above it is seen that the transfer orders are yet to be complied with. This has been viewed very seriously by the Competent Authority.

AN/II/2153/Gen dated 16.07.2013 (copy enclosed) wherein it has been explicitly mentioned that in case of necessity arising out of retirement/ posting/ leave etc Controllers may attach an officer from nearby office/station to an AO GE office till posting of a permanent SAO/AO by the HQrs office.
- 4. In view of above, it is therefore requested to relieve the officers immediately under intimation to HQrs. office, so that complete cycle can be maintained.

IMPORTANT CIRCULAR

Sub: Local transfers: SAOs/AOs.

Ref: HQrs circular No.AN/II/2153/97-CG dated 08.01.1997.

In terms of HQrs circular cited above, Controllers are empowered to effect local transfers in respect of SAOs/AOs serving under their organisation.

- 2. With the upgradation of AAO GEs to AO GEs, the postings to these offices are also being centrally controlled and are effected after a careful scrutiny of the officers' profile. It has however come to notice that local changes are being effected by some Controllers which renders the exercise futile.
- 3. It is therefore brought to the notice of all the concerned Controllers that henceforth, no local transfers may be effected involving AO GE offices without prior concurrence of HQrs office. However, in case of necessity arising out of retirement/posting/leave etc, Controllers may attach an officer from nearby office/station to an AO GE office, till posting of a permanent SAO/AO by HQrs office.
- 4. Controllers are however permitted to make changes in main office and between main office and other sub-offices in the same station under intimation to HQrs office. While intimating the local transfer, the name of the substitute provided for the officer being transferred may also be invariably mentioned.
