

Minutes of the 23rd Annual Meeting of DASCB

The 23rd Annual meeting of Defence Accounts Sports Control Board was held on 10th Aug 2022 at 10.00 hrs in HQrs Office and the following Officers were present.

2. At the outset, Chairperson DASCB welcomed all the members of the Board.
3. Minutes of the 22nd Meeting of DASCB held on 04.03.2020 was discussed.
4. The Annual sports calendar for the year 2022-23 was discussed. The sports calendar for every financial year will be decided well in advance and uploaded on CGDA website. For financial year 2022-23, it was decided to hold the following tournaments:
 - (i) All India DAD Badminton Tournament will be organized in the month of November 2022.
 - (ii) All India DAD Cricket Tournament will be organized in the month of Feb/Mar 2023. Zonal Cricket Tournaments will be organized at five zones in the month of Dec 2022. Winners of Zonal Cricket Tournament will qualify and participate in the All India DAD Cricket Tournament.
5. The modalities, Venue and date of the All India DAD Tournaments 2022-23 will be worked out and proposed for approval of Competent Authority. This exercise should be completed by 15th of September for Badminton tournament and by 30th November for Cricket Tournament.

6. Some of the members proposed to introduce DASCBS awards for excellence in sports. Similar awards for recognizing the efforts and accomplishments of sports personnel are instituted in many other ministries and departments. It was decided that complete modalities for instituting these awards would be worked out and placed for approval of Competent Authority on file. The first such Awards to be given on DAD Day 2023.

7. Provision of Sports & recreation facilities for staff in DAD residential complexes was discussed. CGDA and Chairperson DASCBS remarked that efforts to provide the facilities can be made by the body. PCDA/CDA offices indicate and provide above facility in their respective offices & residential complex.

8. DASCBS decided that the active sportspersons will be provided additional facilities including relaxation in office timings for their preparation and participation in DASCBS/State/National level tournaments. List of active sports personnel will be prepared annually in consultation with PCDA/CDA offices on the basis of participation/performance of players. The complete guidelines on relaxation in the office timings and provision of additional facilities etc will be issued in the due course after approval of the Competent Authority.

9. A proposal for modification/change in DASCBS logo was discussed in the meeting. The Chairperson directed DASCBS to take professional help in designing the new logo.

10. Sh. Anand Agrawal, Member Western Region & Director NADFM Pune proposed that a separate team of IDAS Officers may be allowed to take part in All India sports event. Chairperson DASCBS agreed to the same for individual sports and team events as per the availability of IDAS Officers.

(Action: DASCBS Section)

11. Shri Mayank Bisht, Member Central Region proposed that the separate Tournament for Badminton, Golf & Table Tennis may be organized for IDAS Officers. Chairperson agreed to it in principle. The modalities is to be finalized separately later.

(Action: DASCBS Section)

12. Members proposed that PCDA/CDA offices should allow sportspersons to participate in All India Civil Services/State/National/International level tournaments and due recognition/awards may be given to the sportspersons who has excelled/won medals at appropriate level. Chairperson agreed to it.
