At the outset, Jt. CGDA (Admin) welcomed all members of the Associations and others present to the 49th Main Meeting. Jt. CGDA (Admin) congratulated the staff side on the occasion of silver jubilee year of JCM III level. Thereafter, Shri Dangi one of the III level staff side member, who is retiring in July 2016, was felicitated by the CGDA.

The minutes of the 48th Main Meeting held on 08.02.2016 were confirmed. Thereafter, action taken points of 48th Main Meeting were taken up for discussion.

2. Action taken on Minutes of 48th MM III level of CGDA HQrs. held on 08.02.2016.

(i) Non Graduate MTS having minimum qualification of 12th standard should be allowed to Departmental clerk examination after completion of two years of service.

Reply: MoD(Fin) has asked this office to forward the proposal after notification of corrigendum Recruitment Rules for the post of Auditor, which is under examination with MoD. Corrigendum recruitment Rules for the post of Auditor has not yet been approved by the MoD(Fin). The proposal will be submitted to MoD after the approval of the above.

(Action: AN-VIII Section)

(ii) One increment may be allowed to Auditors who have passed SAS Part-I Examination.

Reply: In absence of availability of specific provisions with regard to grant of one increment to auditors on passing SAS part-I examination in relevant RRs and that other Organized Accounts Services are also not allowing similar incentive. It is not feasible to accede to the request.

(iii)(a) One more workshop on JCM matter to be conducted by CGDA office shortly.

(b) Based on the JCM workshop conducted by the CGDA office, all Regional Training Centres of our Department should be directed to hold JCM workshop at the earliest.

Reply: (a) One day workshop on functioning of JCM organized on 24.05.2016 at HQrs. office.

(b) All RTCs have been advised to conduct a workshop on JCM matter.

(iv) Permanent Identity Card for DAD Employees.

Reply: The matter has been taken up with MoD.

(Action: AN-III Section)

(v) Separate review meeting on the transfer policy should be summoned at the earliest.

Reply: The chair has advised the staff side to submit specific points on which discussion is required, so that the matter may be considered.

(Action: AN-IX/X Section)

(vi) Clear directive to all PCsDA/CsDA to publish their respective Transfer policy being strictly followed as per HQrs. Norms.

Reply: Necessary directions have already been issued to PCsDA/CsDA.

(Point Dropped)

3. Agenda points discussed in 49th Main Meeting

(i) Separate examination for disqualified candidates- MTS

Educationally qualified MTS have been disqualified on technical reason. One more examination to be conducted immediately to give opportunity to these technically disqualified candidates.

Reply: The chair directed official side to consider holding of Examination at the earliest (i.e. within three or four months).

(Action: AN- SAS Section)

(ii) SAS part I and part II examination to be held on at par with the SAS examination conducted in IA & AD.

Reply: It was intimated by the official side that pattern of SAS examination conducted by IA&AD is entirely different hence, it may not be feasible to conduct SAS examination in the line of IA&AD. During the discussion the staff side projected that the existing examination system is pretty old and needs relook. The chair has directed the official side to review the present system.
