Subject: Training & Development Policy 2019: Amendment thereto.

This is with reference to the Agenda point Sl. No- 1.20 & 2.5 of the Minutes of the Inter RTC Meeting held on 16th February, 2022 under the Chairmanship of Sr. Jt. CGDA (P&E) and uploaded on WAN on 28th March, 2022. As per Agenda Point 1.20 & 2.5, a need for fixing a uniform pattern of exam and passing/qualifying criteria in the following training program was discussed.

- i) Two weeks training course for promotion from Auditor to Sr. auditor- Test Regarding.
- ii) Induction course for Newly Recruited Auditors/Clerks- Confirmatory Test Regarding.
