Subject: Promotion of Clerks to the grade of Auditor

58 (Fifty Eight only) Clerks as per Annexure ' A ' to this letter, who have been recommended as 'Fit' by the DPC held in respective offices, have been approved for promotion to the grade of Auditor in the pay Matrix-5 (Erstwhile Pay Band-1 with Grade Pay of Rs.-2800/- as per VI CPC) with effect from 01.04.2017 or from the subsequent date on which they assume the charge.

Further ,20 (Twenty only) Clerks as per Annexure `B' have also been considered for promotion to the post of Auditor, but before promoting the Individuals, Controllers are requested to ensure that they have either passed the Typing Test or get exemption from Typing Test in terms of DOP&T OM No. 14020/3/95-Estt(D) dated 14.09.1995 read with DOP&T OM Dated 29.09.1992 and accordingly the action as deemed fit may be taken in terms of these OMs at your end.The APAR Gradings for 2015-16 may also be finalized before promoting Clerks at Sl. No.4,18 and 19 of Annexure `B'. Action taken may be reported to the HQ Office immediately.

2. The promotion may please be notified in the name of PCsDA/CsDA as Appointing Authority in office order. Before promoting the individuals, it may be ensured that none of the circumstances enumerated in Para 2 of the DOP&T OM No. 22011/4/91-Estt.(A) dated 14/09/92 have arisen before promotion. If such circumstances have arisen, the promotion shall not be released and instead treated as "Deemed Sealed Cover" case in terms of Para 7 of the said OM. At the time of notification of their promotion, it may also be ensured that they are not undergoing penalty i.e reduction to the lower stage of scale of pay or stoppage of increment etc.If the promotion is not notified for any reason, this fact may be brought to the notice of HQ Office immediately.

3. It is also requested to re check the service particulars of the individuals furnished in the adjudication reports to ensure their correctness and that they have correctly been adjudicated as "Fit" before notifying their promotion ,the case of discrepancy found, if any, the Controllers are advised to refer the matter to this office for necessary action.

4. Cases of refusal of promotion, if any, may be dealt with by the Controllers themselves in their capacity as an Appointing Authority in the light of provision contained in DOP&T OM No. 22074/3/81-Estt.(D) dated 01/10/81 and this HQ circular No.AN/XII/12201/0/3/87 dated 24.11.87

5. While issuing order of promotion, attentions of the individual may please be drawn to the provisions of Ministry of Personnel, Public Grievances and Pension(DOP&T) OM No.1/12/97-Estt. (Pay-1) dated 23/4/99 and clarification No.2 of GOI,Ministry of Finance, Department of Expenditure No. 01/01/2008-IC dated 13.09.2008 regarding exercising of an option by them for fixation of their pay as Auditor
