Dear Shri Sukul,

As you are aware, the National Institute of Financial Management has been set up by the Government of India for professional training of officers of Group 'A' Accounts and Finance Services of Government of India. The Institute, besides training probationers of the Central Group 'A' Finance and Accounts Services also conducts a large number of Domestic & International Management Development Programmes. In addition, the institute conducts a two-year full-time Post Graduate Diploma in Management (Financial Management) and one-year Diploma in Government Accounting and Internal Audit for officers of Central and State Governments/PSUs etc. both approved by AICTE.

In view of its unique mandate, the institute requires an optimal mix of faculty, from academia as well as from Government.

The senior Government officers on its faculty not only provide academic inputs to the probationers/officer trainees but also serve as role models for the young officers. The Memorandum of Association of NIFM lists the following six-services as participating services – IA&AS, ICAS, ICoAS, IDAS, IP&TAFS and IRAS. Ideally, NIFM should have at least one officer from each of the six participating services. This would not only enable a more comprehensive input to the probationers on the role of Accounts and Finance Services in Government of India, but also enable NIFM in designing focused training programmes that can better address the mid-career training needs of all Accounts and Finance Services, and foster greater inter-services interaction.

The institute has vacancies in the positions of Professors (1 Vacancy: Level-14 of 7<sup>th</sup> CPC), Associate Professors (SG) (1 Vacancy: Level-13 of 7<sup>th</sup> CPC) and Associate Professors (1 Vacancy: Level-12 of 7<sup>th</sup> CPC Pay Matrix) for officers on deputation.

Presently, we do not have any IDAS on our faculty. You may like to encourage your officers to come on deputation to NIFM and fill this gap.

Deputations to this institute are governed under DoPT order No. 2/29/91-Estt.(Pay II) dated 5<sup>th</sup> January, 1994 as amended from time to time. Offices on deputation to this Institute are also entitled to training allowance at the rate admissible under Government of India, Ministry of Personnel, Public Grievances and Pension, DoPT OM No. 12017/2/80/Trg dated 9<sup>th</sup> July, 1992. The Institute also has provision of accommodation for faculty in the campus. A copy of the Faculty Recruitment Rules is enclosed. The RRs for faculty on deputation to NIFM from the participating services requires Group-A officers with 14 years of service for Professor, 12 years for Associate Professor (SG) and 7 years for Associate Professor.
