

Subject:-Extension of Modified Assured Career Progression Scheme to the
Civilian Motor Drivers (CMDs) in Defence Establishments.

Vide MoD I.D. No.11(3)/2009-D(Civ.I) dated 3.8.2010 a copy of DOP&T's O.M. No.35011/03/2008-Estt.(D) dated 30th July, 2010 regarding Extension of Modified Assured Career Progression Scheme to the Staff Car Drivers of Central Government was forwarded for information & necessary action in respect of Defence Civilian Employees paid from Defence Services Estimates.

2. It is clarified that as already communicated vide the aforesaid I.D note dated 03.08.2010, the provisions contained in DOP&T's O.M. dated 30.7.2010 are equally applicable to Civilian Motor Drivers (CMDs) in Defence Establishments, including the provisions in para 2 of DOP&T's O.M of 30.07.2010 regarding the benefit of MACPS being admissible as a **fall back option, if they are unable to get promotion within the percentage based present system.**

3. This issues with the approval of Defence (Finance/AG/PB) vide their U.O.No.28/AG/PB dated 20.01.2011.

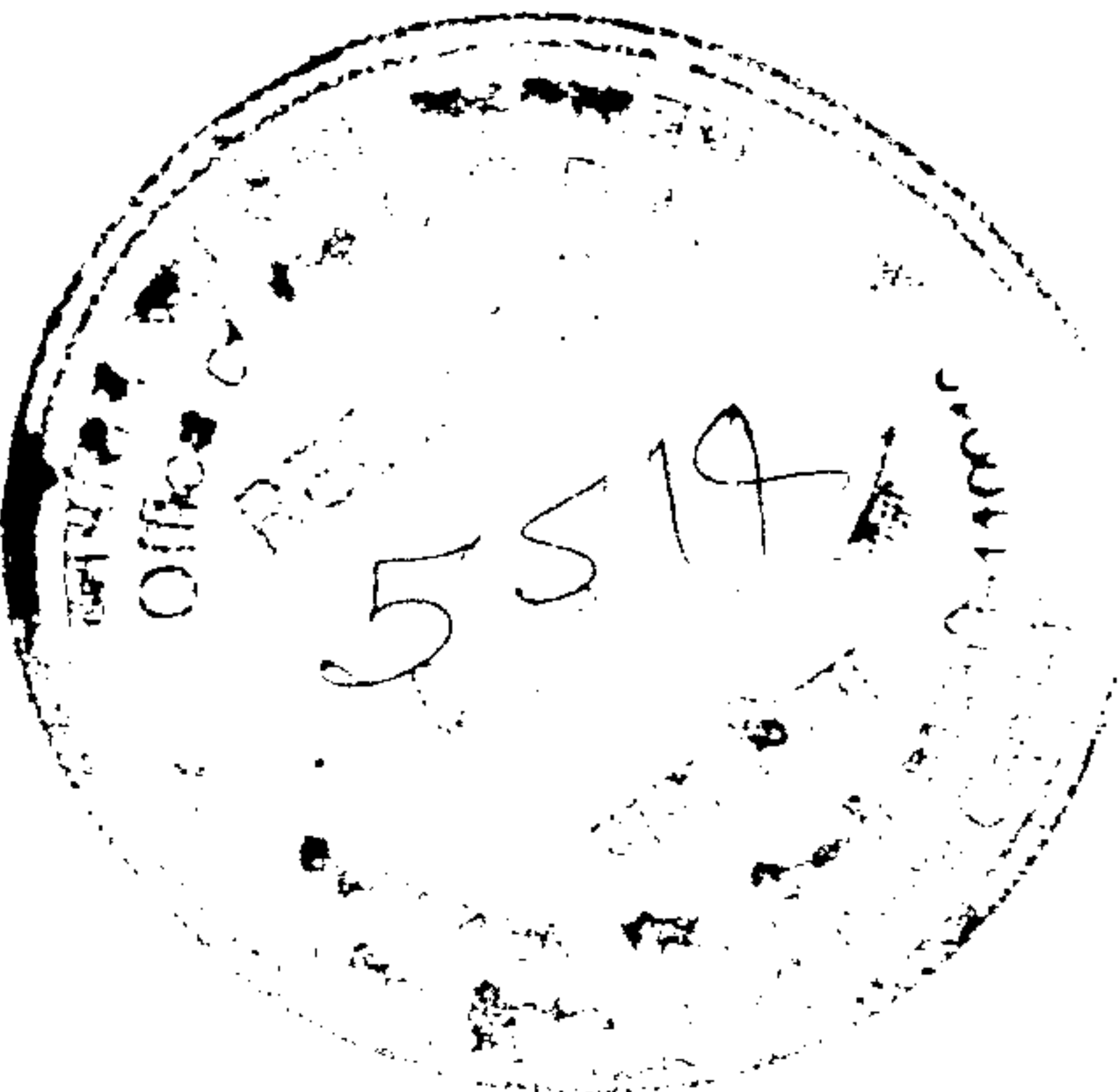
