Subject Modified Assured Career Progression Scheme (MACPS) for the Central Government Civilian Employees - Extension of the benefits to Officers of HAG Scale of ₹67,000-79,000/-

Reference is invited to the Department of Personnel & Training's O.M. of even number dated the 19th May 2009 wherein the financial upgradation under the Modified Assured Career Progression Scheme (MACPS) has been allowed upto the highest grade pay of ₹12000 in the Pay Band 4. Consequent upon introduction of the new HAG scale of ₹67,000-79,000 in replacement of ₹37,400-57,000 with grade pay of ₹12000 in PB-4, it is clarified that the benefits of financial upgradation under the MACPS shall be available to aforementioned HAG scale also.
