Twenty nine (29) officers of the Indian Defence Accounts Service, as indicated in **Annexure 'A'** of this letter, have been approved for promotion to the Junior Administrative Grade [in the pay level 12 of the 7th CPC pay matrix (Rs. 78800 to Rs. 209200)] in IDAS. The Competent Authority has decided the posting on promotion in the Offices/Organizations as indicated against their names. The officers, may, therefore, be relieved of their present duties immediately. On assumption of charge, the officer(s) may be promoted to the Junior Administrative Grade (in the pay level 12 of the 7th CPC pay matrix (Rs. 78800 to Rs. 209200)) of the Indian Defence Accounts Service.

2. It may also please be confirmed before promotion of the officers in the Junior Administrative Grade of the IDAS that no disciplinary/criminal case is pending against the officers and the officers are not under suspension.

The Pr. Controllers/PIFAs/Controllers/IFAs may also ensure that representations are not unduly forwarded.

6. TA and joining time as admissible under rules may be authorised to the officers.
