
Subject: Promotion of Steno-II to the grade of Steno-I for the vacancy year 2021

3. The case of refusal of promotion may please be dealt with by PCDA/CDA office itself being the appointing authority in light of provisions contained in DoP&T OM No. 22034/3/81-Estt(D) dated 01.10.1981. This HQrs office may please be informed accordingly.


4. It is requested to forward a copy of Part II Office Order notifying the promotion from Steno Grade-II to Steno Grade-I.


