**Subject: Promotion to the grade of Principal Controller of Defence Accounts (Higher Administrative Grade) alongwith transfer/posting in HAG & SAG of the Indian Defence Accounts Service.**

Consequent upon the approval of promotion in respect of the SAG level IDAS officer to the grade of Principal Controller of Defence Accounts (HAG) of the Indian Defence Accounts Service in the level-15 of 7<sup>th</sup> CPC pay matrix, it has been decided by the Competent Authority to post him in the office as reflected against name of officer in **Annexure 'A'** to this letter.
