Subject: **Promotion of Graduate Clerks-cum-Typists & Graduate MTS to Auditor grade on passing Departmental Examination held on 02nd June, 2022.**

Reference: in continuation of HQrs letter No.even Dated: 22.12.2022

01(one) Graduate Clerks-cum-Typists & **05 (five)** Graduate MTS as per Annexure-'A' to this letter, who have been recommended as 'FIT' by the DPC held in respective offices, have been approved for promotion to the grade of Auditor in the Pay Scale of Rs.5200-20200(PB-I) with grade pay of Rs.2800/-(Level-5). As per **Annexure-'A'** **their promotion with effect from the date mentioned against their names or from the subsequent date on which they were present in office** whichever is later in the same organization where they are serving at present.

2. The promotion may please be notified in the name of PCDA/CDA as Appointing Authority in the Office order. Before promoting the individual, it may be ensured that none of the circumstances enumerated in Para 2 of DOP&T OM No.22011/4/91-Estt (A) dated 14.09.1992 have arisen before promotion. If such circumstances have arisen, the promotion shall not be released and instead treated as "Deemed Sealed Cover" case in terms of Para 7 of the said OM. At the time of notification of their promotion it may also be ensured that minimum of three years of service in terms of Recruitment Rule for the post of Auditor has been completed by the individual and they are not undergoing penalty i.e., reduction to the lower stage of scale of pay or stoppage of increment etc. If the promotion is not notified for any reason, this fact may be brought to the notice of this HQrs. The service particulars of the individual furnished in the adjudication report of the DPC may again be verified/checked to ensure the correctness of records before issues of promotion.

3. The case of refusal of promotion may be dealt with by office itself, being the Appointing Authority in light of provisions contained in DOP&T OM No.22034/3/81-Estt(D) dated 01.10.1981. The HQrs. office may please be informed accordingly.

4. While issuing order of promotion, attention of the individuals may please be drawn to the provisions of Ministry of Personnel, Public Grievances and Pension (DOP&T) OM No.1/12/97-Estt.(pay-I) dated: 23.04.1999 and clarification No. of GOI Ministry of Finance, Department of Expenditure No. 01/01/2008-IC dated 13.09.2008 regarding exercising of an option by them for fixation of their pay as Auditor.

5. It is requested to provide the details of candidates as per HQrs letter dated 10.10.2022 alongwith copy of part II Office Order notifying the promotion from Graduate Clerks -cum -Typists /Graduate MTS to the grade of Auditor.


