Subject: Promotion of Auditors to the Grade of Sr. Auditor.

412 (Four hundred and twelve only) Auditors listed in Annexure "A" to this letter, who have been recommended "Fit" by the DPC held in your office, have been approved for promotion to Sr. Auditor's grade in the scale of Rs. 9300-34800 with grade pay Rs. 4200/- w.e.f **01.04.2013** or from the subsequent date on which they are present. While promoting the concerned Auditors, they should be informed through the order of promotion as distinct from Part II Office Order that the required option for fixation of pay shall be exercised within one month from the date of assumption of charge of promotion failing which they will be deemed to have opted for fixation of pay w.e.f the date of promotion in terms of DOP&T OM No. 1/12/97 Estt. (Pay-I) dated 23.4.99 and clarification No. 2 of Govt. of India, Ministry of Finance F. No. 1/1/2008-IC dated 13.09.2008.

2. Before promoting the Auditors, it may please be ensured that none of the circumstances enumerated in Para 2 of DOP&Ts OM No. 22011/4/91-Estt. (A) Dated 14.9.92, have arisen before promotion. If such circumstances have arisen the promotion shall not be released and instead treated as a "Deemed Sealed Cover" case in terms of Para 7 of the said OM. It may please be ensured that none of the Auditors who are undergoing the period of penalty are promoted till the expiry of the period of penalty. The promotion order notified by your office should also indicate that they have been promoted to the grade of Sr. Auditor by the PCsDA/CsDA as Appointing Authority. Under no circumstances should it be mentioned that they have been either selected or cleared by the CGDA for promotion, this position being factual. Accordingly, reference of this letter should be strictly avoided in the promotion orders and Part II Office Orders.

3. The Controllers are requested to take immediate action to finalize the deferred cases, if any, and send their adjudication reports without any further delay to obviate avoidable representations from concerned individuals.

4. The Controllers are also requested to again re-check the service particulars of the individuals furnished in the adjudication reports to ensure their correctness and that they have correctly been adjudicated as "Fit" before notifying their promotion.

5. The promotion may be notified in Part-II Office Order in due course after assumption of charge of the concerned Auditors as Sr. Auditors and endorsed to this office.
