**Subject: Provisioning of Auditors/Senior Auditors who have passed SAS Part-II examination held in May 2014 to the regular vacancies of Section Officer (Accounts)**

It has been decided to promote the Auditors/Sr. Auditors who have passed SAS Part-II examination held in May 2014 as per Annexure "A" **{Total 150 officials}** to this letter, to the grade of Section Officer (Accounts) in the Pay Band - II of Rs. 9300-34800 with grade pay 4800/-with immediate effect or from the date of assumption of charge of post of SO (A) whichever is later.

2. Before promoting individual to the grade of SO(A) it may please be ensured that none of the circumstances enumerated in Para 2 of the DOP&T OM No. 22011/4/91-Estt. (A) dated 14/09/1992 have arisen. If such circumstances have arisen the promotion shall not be released and instead considered as if, the recommendation of the officials has been placed in Sealed Cover by the Departmental Promotion Committee, in terms of Para 7 of the said OM and an intimation to this effect be given to HQrs.

3. The officials may be relieved of their duties immediately with directions to report to the new office of posting to receive their promotion in the grade of Section Officer (Accounts). In this connection, it is stated that the representations received from individuals requesting for retention/posting to their choice stations on promotion have been taken into consideration and accommodated to the extent administratively feasible. Office of posting if any wherever not specified in the Annexure may be obtained by the relieving office from the concerned PCsDA/CsDA immediately and relieve the officer thereafter immediately to receive his/her promotion.

4. The SO (A) will be on probation for period of two years from the date of assumption of charge.

5. The relief of the individual may not be held up for want of decision on the representation if any, submitted by the individual. In this connection this office circular No. AN/X/10001/2/96/Vol.I dated 12.4.1996 refers.

6. PCsDA/CsDA/ IFAs etc are requested to make necessary arrangement for the orientation training program of the newly promoted Section Officer (Accounts) in consultation with the Training Division/RTCs.

7. PCsDA/CsDA/IFAs are requested to forward copies of Part. II O.O notifying the promotion recording to AN-IX & AN-XI sections of HQrs. separately for recording the date of SOS and reporting. TA/DA and joining time as admissible under rules is authorized.

8. Transfer orders issued recently in respect of candidates who have qualified SAS-Part-II examination held in May, 2014 and whose promotion-cum-posting orders are now being issued; may please be treated as cancelled.

9. No separate promotion order will be issued in this regard.


