OFFICE MEMORANDUM

Subject: Reservation of seats to Physically Disabled Persons in administration to Post Graduate Diploma and Certificate Course conducted by Government/Government aided Institutions- reg

The undersigned is directed to say that Government aided references are being received in this Department seeking advice on applicability of reservation for Persons with Disabilities in academic courses run by Government/Government aided Organizations. It is clarified that as per Section 39 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, Government educational institutions and other educational institutions receiving aid from the Government shall reserve not less than 3% seats for Persons with Disabilities. It is also clarified that if the number of seats in any single course is small, then the Institute may pool the seats of such courses and reserve 3% of the pooled seats. It is further clarified that the reservation in admissions is available to all the categories of disabilities and there is no separate percentage/quota for any particular disability.

2. It is, requested that all the Government/Government aided educational institutions offering academic courses under the administrative control of your Ministry/Department may be advised accordingly to ensure implementation of the above provision of the Persons with Disabilities Act, 1995. Action taken in this regard may be intimated to this Department at the earliest.
