3. They may please be relieved of their duties in your organization and instructed to report to the new office of posting provided nothing adverse against them has come to your notice and the Part-II Office Order may be published simultaneously.

4. In case the transfer list includes any AAO upto R.No. 661 in General Category & AAOs up to 1376 for reserve category (Roster of 2012) may be relieved only after seeking confirmation from the HQrs.

5. All outstation transfers are on "State Expense" and hence TA/joining time as admissible under rules is authorized. Local transfers may be regulated as per laid down rules.

6. Where office of posting of an officer has not been indicated, the same may be obtained from the concerned controllers before relieving the individual.

7. Where the officer is posted at hard tenure station he may be relieved after completion of mandatory physical stay at present station.






