Subject: Implementation of Government's decision on the recommendations of the 7th CPC-Revision of pension of pre-2016 Non DAD Defence Civilian Pensioners/ Family Pensioners, etc.

Reference: This HQrs office letters of even No. dated 12-10-17 and 21-11-2017 and Letters No AT/II/2701/Orders dated 10-11-2017 and 13-11-2017.

In continuation of HQrs office letters cited above, as per HQrs Office letter AT/V/DAD/15101/Circular/2017 dated 22-11-2017 instructions have been issued in the light of decisions taken in the review meeting held on 1st Nov 2017 under the chairmanship of Defence Secretary. As per one of the decisions taken in the said review meeting, CGDA is to prescribe targets to the Controllers' Offices for disposal of cases received from HOOs and the progress made thereof is to be reviewed by HOO/CGDA every fortnight. In view it is requested to ensure that all the cases submitted by units/formations are audited/vetted within a week of their receipt.

2. As per HQrs Office letter dated 12-10-2017 it was requested to forward a fortnightly report on the subject i.e. on 1st and 16th of every month. However, the said report due on 16th Nov 2017 has not been received till date from many of the controllers; **please ensure that the fortnightly report due on 1st Dec 2017 may be furnished to this HQrs office immediately without delay on hqaudit.cgda@nic.in.**

3. As per HQrs Office letter dated 12-10-2017 it was also requested to nominate a nodal officer in your office for effective monitoring of the exercise of revision of pension/family pension of Pre- 2016 pensioners; however, till date only 5 Controllers' Offices have furnished the details of the nodal officer nominated in their offices. It is requested to intimate the details of the nodal officer nominated in your office for the purpose in the next report.

4. While forwarding the subject fortnightly report it may be ensured that the details of cases received and cleared by sub offices are also included in the figures being forwarded to HQrs Office. Further, in the report due on 1st Dec 2017, the organisation wise figure of cleared cases in respect of Non DAD Defence Civilians may also be shown as footnote in Annexure 'A'. Moreover, the figure being shown in the column (3) depicting the total No of pensioners in the report of your office may be reconciled to the most possible extent with the figure shown in the column of 'Living Pensioners' in the report available at link 'MIS on Pre-16 Civilian Pension' at the website of PCDA (P) Allahabad.

4. The desired report may be sent only through CGDA mail server (hqaudit.cgda@nic.in). **NIL** report is also required.


