Subject: Provision Of Residential Telephones To Lt Cols Posted In Army

Sir,

1. I am directed to say that the matter regarding provision of residential telephones to Lt Cols posted in the Army has been considered and it has been decided with the approval of the competent authority that Lt Cols in the Army may be provided residential telephone. The facility of residential telephone may be given from Army Network wherever, it is possible.

2. It has been further decided that those entitled officers who have not been provided residential telephone by Army Network may claim reimbursement from the concerned regional CDAs through their respective contingency grants allotted to the fm/ unit/est as per ceiling i.e. Rs 1500/-pm and other stipulations laid down in Ministry of Finance OM No 7(14)/ (C&V)/2006 dt 14 Nov 2006, and corrigendum/amendments issued from time to time subject to concurrence accorded by the local IFAs in each case.

3. This issues with the concurrence of Ministry of Defence (Finance Division) vide their ID No 47/Fin/GS/10 dated 12 Jan 2010.
