

Subject: Delegation of powers to accord concurrence within the IFA set-up

Reference: HQrs office's letters (i) No. File: IFA/1 dated 02.02.2011 (Instruction No. 03 of 2011) & (ii) No. IFA/03/Army Coverage (Del of Power)[CN-57] dated 30.04.2019 (Instruction Order No. 05 of 2019).

With reference to the above cited communication it is stated that the letter at reference (ii) above had been issued specifically in respect of below Command level IFA offices. The instructions contained therein regarding delegation of financial powers within IFA setup pertained to those below command level IFA offices where the appropriate level/rank IFAs had not been positioned.

2. It is clarified that the earlier instructions on delegation of powers to accord concurrence within the IFA set-up at Service HQrs and Command HQrs/Border Roads HQrs and Coast Guard HQrs, which had been circulated vide the letter at reference (i) above, remain unchanged.
3. It is advised that strict compliance of the above mentioned instructions may be ensured.

Sub: Delegation of powers to accord concurrence within the IFA set-up.

The Competent Authority has decided to delegate powers to accord concurrence within the IFA set-up at Service HQrs/Command HQrs/Border Roads HQrs and Coast Guard HQrs level as mentioned below:-

Level of CFA	Level at which concurrence would be accorded

(c) Coast Guard	
DG/DDG	IFA
Pr. Director/Dir (Adm)	Addl. IFA/Jt. IFA/Dy. IFA

2. The above delegations shall also be applicable for concurrence of works cases.

3. When PIFA/IFA is not posted or away on temporary duty etc. and there is no link PIFA/IFA, then the Addl IFA/Jt IFA who is next below will deal with the cases which would have been dealt with by the PIFA/IFA.

4. Where no dedicated IFA is posted for an establishment/unit, the nominated CDA/Addl. IFA/Jt. IFA/Dy IFA will continue to accord financial concurrence, as hitherto.

5. PIFA/IFA shall carry out an internal fortnightly review of the work done by the Addl. IFA/Jt. IFA/Dy IFA. This exercise should be carried out as an internal corrective/advisory exercise but should not disturb any concurrence which has already been accorded by the latter under their delegated sphere.

6. The composition of TPCs/CNCs/PNCs when approved by the CFA should indicate that 'representative of IFA' will attend the same so that an appropriate level officer can be detailed for the meeting by the PIFA/IFA.

7. The system will be reviewed after one year of implementation.


