CLARIFICATION ON SCHEDULE 10.1 DFPDS-2016

1. Based on persistent inputs received from the environment about the restrictive interpretation of Sub Schedule 10.1 of DFPDS 2016 by IFAs thereby denying Brig(IS) of Comd HQs their delegated powers under said Sub Schedule, the matter was referred to MoD(Fin) for a clarification in the matter.

2. MoD (Fin) have since issued a clarification in the matter to the effect that **under** schedule 10.1 of ASP-2016, apart from others, Brig (IS) and Brig GS (ARTRAC) are both CFAs with financial powers of Rs 2 lakh without IFA consultation and Rs. 50 lakh with IFA consultation. **Brig (IS) is to exercise this power in r/o all concerned HQs except ARTRAC.** A copy of MoD(Fin) ID No. 8/4/02P/2017 dated 18 Aug 2017 in this regard is enclosed for your information and guidance.



The matter has been examined and it is clarified that, under schedule 10.1 of ASP - 2016, apart from others, Brig (IS) and Brig GS (ARTRAC) are both CFAs with financial power of Rs 2 lakh without IFA consultation and Rs 50 lakh with IFA consultation. Brig (IS) is to exercise this power in r/o all concerned HQs except ARTRAC. In case of ARTRAC these powers are to be exercised by Brig GS (ARTRAC).
