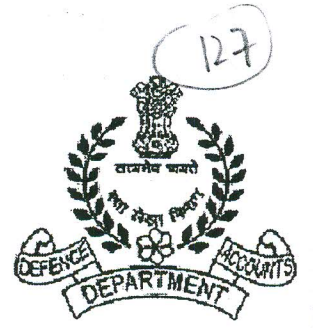

**Sub : Interpretation of Schedule 22.5 in AFSP-2015.**

\*\*\*\*\*

IFA, 7BRD/27ED (AF) has received a number of cases for placing of AOG/PHU/MCM requisition on Defence PSUs for indigenous items under Schedule 22.5 of AFSP-2015. The schedule has heading as "Non Procurement Powers". IFA, 7 BRD/27ED (AF) has stated that since the schedule shows non-procurement powers, indent cannot be placed on DPSUs under this schedule (22.5).

However, this activity was done under Schedule XII Q as per DFP issued vide GoI/MoD No. 10(3)/02-D(Air-II) dated 01/04/2012 reiterated in Schedule XII(O) as per DFP issued vide GoI/MoD No. Air HQ/95378/1/FMP/2431/US(RC)/Air-II/06 dated 14/07/2006 and now mentioned at Schedule 22.5 as per DFPDS-2015. Although, the nomenclature mentioned in various schedules are similar. This is now shown under non-procurement heading.

This office is of the opinion that as per Para-10 of Part-B of DFPDS-2015, based on existing SOP and practice requisition can be placed for indigenous procurement through DPSUs as was done previously.

Previously, this activity was done under Schedule XII(O) following the SOP for XIIQ.



It is opined that as there is no other schedule in AFSP-2015 covering this activity, the indents should be placed under Schedule 22.5 only.

It is requested to kindly confirm these views.
