**Sub: Hiring of CHT in COD: clarification regarding.**

The matter is regarding hiring of periodic rate contract.

2. As per Para-2 of PIFA instruction No.-7 of 2009 issued vide PIFA/Gen cors/IFA(O)/Vol-II dated 22-05-2009, 'Periodic Rate contract' are to be sanctioned by Comdt COD/OD/FAD etc in consultation with IFA/CDA under Sl. No.-4 of the Schedule-XXII of DoFP-2006, but the same has not been incorporated in DFPDS-2015 and Comdt CODs have been delegated Fin Powers of ₹40/-lakh for conclusion of contract under Schedule-I of ASP to DFPDS-2015. This financial power to Comdt COD has been delegated for conclusion of contract and not for Periodic Rate contract and there is no higher CFA in the line directorate hierarchy under the ibid schedule for conclusion of contract valuing more than ₹40/- lakhs.

3. Keeping in view above, HQrs office is requested to issue necessary clarification/guideline that who would be the next CFA for periodic Rate contract where anticipated value exceeds ₹40/-lakhs w.r.t. Para-8.4.1 of DPM-2009, because GOC Jabalpur Area is not willing to accord sanction of CHT for COD Jabalpur stating reason that funds of CHT to COD Jabalpur is being received from the line directorate of CODs, when the rate Contract of CHT is more than one crore which is much above the power of Comdt COD.

Ref: Your letter No.IFA/CC/1046/Functioning/Vol-VII Dt. 30.03.2016.

The issues as brought out in your letter cited under reference has been examined in the light of provisions of DFPDS-2015 and it is stated that if the anticipated value exceeds Rs. 40 Lakh at COD level, the next higher CFA in Ordnance Side would be MGAOC & GOC having delegated financial powers of 75 Lakh & 200 Lakh respectively under Sch -I of ASP-2015.

2. However, since DFPDS-2015 is presently under review at Ministry level hence it would be appropriate to wait the final outcome of the Review Committee on DFPDS-2015.
