Competent authority in HQrs office has approved Holding of 8th All India DAD Badminton Tournament (Men and Women) by CDA Guwahati under the aegis of Defence Accounts Sport Control Board during the 3rd week of September 2016 in Guwahati. Accordingly, it has been decided to organize the said tournament w.e.f. 19/09/2016 (Monday) to 22/09/2016 (Thursday).

2. The Tournament consists of following events under categories Sport quota and Non-Sport quota:

1. Singles (Men), 2. Doubles (Men), 3. Singles (Women), 4. Doubles (Women) 5. Mixed Doubles.

3. All Badminton sport quota players will have direct entry in the Tournament.

4. In addition to Sport Quota players, each Principal Controllers/Controllers office may kindly field 3 Men and 2 Women players from their organization for the tournament. No manager/extra players is allowed to accompany.

5. All IFA Offices will be considered as part of the proforma Controller to whom they are attached. They will therefore take part in the internal matches conducted by the respective CsDA organization of qualification.

6. Accordingly, each PCsDA/CsDA/PCsFA is requested to forward details of their team in following format by 06/09/2016 by fax/email.

8. Match fixtures will be prepared by the Chief Referee, Assam Badminton Association using tournament software.

Charges will be within the entitlements and required to be paid by the players. However, the participant may be allowed to draw Hotel rate of TA/DA. Participant willing to make their own arrangement for stay, shall kindly intimate the same by **06/09/2016** by fax/email.

10. The travel plan may be planned in such a way that the teams may not reach Guwahati before **18/09/2016** and leave not later than **23/09/2016**. Each PCsDA/CsDA/PCsFA is requested to forward travel plan of their team by **06/09/2016** by Fax/email.
