Promotion of Clerk to the grade of Auditor for the vacancy calendar year 2019.

Reference is invited to the provisions contained in DOP&T O.M bearing No.22011/4/2013-Estt. (D) dated 08.05.2017 regarding shifting of vacancy year from financial year to calendar year under which crucial date of eligibility will be 1st of January w.e.f 2019. It is stated that the individuals who were holding the feeder post of Clerk on regular basis as on 26.09.2009 have already been promoted to the grade of Auditor. Further, individuals who have been appointed/promoted as clerks after 26.09.2009 would be eligible for promotion to the grade of Auditor after 13 years of regular service. Thus, it appears that no fresh cases would fall in the criteria as provided in the SRO no. 23 dated 03.05.2016.

- 2. It is therefore requested the all eligible cases, leftover cases, if any may be examined and adjudicated as per Annexure 'A'.
- 3. DPC Proceeding along with adjudication report of the eligible clerks in the Performa enclosed with this letter may kindly be sent to reach this HQrs office latest by 31/10/2018. It may also be ensured that no eligible individual falling within the zone of consideration has been left for adjudication.
