Sub: Training for Accrual Based Accounting System (ABAS) for LAOs.

Please refer to the discussion between Shri Satyam Mohan, DADG of the Dte General and Shri R.P. Singh, Joint CGDA, on the subject.

- 2. The 62 Cantonment Boards in the country have shifted their accounting system from single accounting system to Accrual Based Accounting System w.e.f. 01.04.2020, on implementation of Cantonment Board Account Rules, 2020. New Rules provide for complete shift from single entry cash based accounting to the accrual accounting as per the Mercantile System. The Cantonment Board accounting is now IT based cloud system through NIC cloud server.
- 3. To familiarise the auditors at local level with ABAS system, it is proposed to organise a workshop on ABAS module through VC on 22nd April 2022 from 10 AM onwards as per schedule enclosed. The workshop will be conducted by the Accounting Consultants who have been instrumental in developing the accrual system.
- 4. The VC link for the same will be mailed separately.
- 5. You are requested to instruct the controlling authorities to nominate all the concerned LAOs to attend the above mentioned training on the scheduled date and time. An officer of CGDA may also attend the workshop to coordinate between DGDE and faculty through NIDEM.
