At the outset, Jt. CGDA (Admin) welcomed all members of the Associations and others present in the 50<sup>th</sup> Main Meeting (Golden Jubilee Meeting). Jt. Thereafter, action taken points of 49<sup>th</sup> Main Meeting were taken up for discussion.

- 2. Action taken on Minutes of 49th MM III level of CGDA HQrs. held on 26.05.2016.
- (i) Non Graduate MTS having minimum qualification of 12<sup>th</sup> standard should be allowed to Departmental clerk examination after completion of two years of service.

**Reply:** The proposal was forwarded to MoD(Fin) for approval. The same has been returned by MoD. The proposal will be resubmitted to MOD along with draft notification in bilingual form for further necessary action at their end.

### (ii) Permanent Identity Card for DAD Employees.

**Reply:** The issue is still pending with MoD/D(GS-III). In this connection Shri Yatindra Chandela, Desk Officer concerned was contacted on phone to ascertain the progress. It was informed that process will take some more time.

(iii) Separate review meeting on the transfer policy should be summoned at the earliest.

**Reply:** So far no communication has been received from AIDAA(CB) Pune and AIDAEA(HQ) Kolkata on the issue.

### (iv) Separate examination for disqualified candidates- MTS

Educationally qualified MTS have been disqualified on technical reason. One more examination to be conducted immediately to give opportunity to these technically disqualified candidates.

**Reply**: The examination has been scheduled to be held on 17<sup>th</sup> October 2016. Notification in this regard has been issued vide circular no. AN/SAS/6502/MTS-CLK/OCT/2016/PROG dated 31.05.2016.

(v) SAS part I and part II examination to be held on at par with the SAS examination conducted in IA & AD.

**Reply:** A three member committee has been constituted by the CGDA for review of SAS and other Departmental promotion examinations and report is to be submitted within four months. Accordingly, further action will be taken after receipt of the report.

## 3. Agenda points discussed in 50th Main Meeting

## (i) Agenda No. 1: Promotion policy for Auditors and Clerk.

Promotion policy for Auditors needs thorough review- pay and promotions vis-a-vis not only central secretariat but also vis-a-vis Army personnel and promotional avenues in comparison to the similar cadre in C & AG, Railways, Income Tax and other Departments. All other cadres too have better promotion policies, a thorough cadre review will help to sustain the motivation level and retain the talents, reduce the attrition rate especially the new appointments in DAD. Promotion policy should be uniformity in all DAD offices.

**Reply:** Promotion policy for Auditors and Clerks are made as per Recruitment Rules. It was pointed out by the staff side that residency period in the clerks cadre is too long in comparison to other Departments because of which new recruits are reluctant to join in our Department. The official side stated that the recruitment Rules in other Departments have not been revised since 6<sup>th</sup> CPC. However, chairman directed the official side to take up the issue with DoP&T.

(ii) Agenda No. 2: Departmental examination for promotion of Graduate Clerks to Auditor should be held frequently.

**Reply:** As per existing recruitment Rules the eligibility for appearing in the Departmental examination for Auditors Grade is 5 years in respect of graduate Clerks. The last exam was held in August 2014. Chairman directed the official side to conduct the Departmental examination on the analysis of need basis.

(iii) Agenda No. 3: Nearly 70 Nos. of officers & staff posted in AAO Salt Lake. There is no wet canteen arrangement. Employees are coming from distant places but not getting tea or lunch. Matter raised by ROC member. CDA Patna may be directed to arrange wet canteen.

**Reply:** Chairman directed that CDA Patna may be advised to explore the possibilities of the providing canteen service in Area Accounts Office.
