Promotion of Asstt. Accounts Officers to Accounts Officer's grade against the vacancy year 2019.

58 (Fifty Eight) AAOs as per **Annexure-A** enclosed to this letter, have been approved for promotion to the grade of Accounts Officer in Level-9 of Pay Matrix (Pay Band-2 ₹ 9300-34800, Grade Pay ₹ 5400/-, Pre-revised 6<sup>th</sup> CPC) with immediate effect or from the date of assumption of charge to the post of Accounts Officer, whichever is later.

- 2. Before promoting the AAOs to the grade of Accounts Officer, it may be ensured that none of the circumstances enumerated in para 2 of the DOP&T OM No. 22011/4/91-Estt. (A) dated 14.09.1992 have arisen. If such circumstances have arisen, the promotion shall not be released and instead considered as if the case of the officer concerned has been placed in Sealed Cover by the Departmental Promotion Committee, in terms of para 7 of the said OM and an intimation to this effect be given to this HQrs Office.
- 3. Further, AAOs mentioned at SI. No. 46 to 54 of **Annexure-A** have been approved for promotion to the AO's grade against the vacancies reserved for SC/ST candidates. Accordingly, as per para 05 of DoP&T F No. 36012/11/2016-Estt.(Res-I){Pt-II} dated 15.06.2018, while releasing promotion in respect of these reserved category AAOs, it may be mentioned that the promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court in SLP(C) No. 30621/2011, SLP(C) No. 31288/2017 and other such related court cases. It is also requested that caste verification in respect of these reserved category AAOs may be carried out as per provisions contained in DoP&T OM No. 36011 /3 / 2005-Estt (Res) dated 09.09.2005 and before notifying the promotion, necessary undertaking

as per this HQrs Office Circular No. AN/II/2151/PC-1089 (N) dated 11.01.2013 may be obtained from the officers concerned.

- 4. Relief of the officer shall not be deferred on the ground that representation has been submitted for change of place of posting or on the ground that relievers have not reported / been posted. It may be brought to the notice of the officers that all efforts have been made to accommodate them at the choice stations preferred, to the extent of administrative feasibility.

If an officer is under order of transfer and he / she is yet to relieve from the previous organization, the said transfer order may be treated as cancelled. The organization under which such AAOs are posted as on date may relieve the officer accordingly.
