Subject: **Promotion from the grade of Senior Accounts Officer (Group 'B') to the Junior Time Scale (Group 'A') of the Indian Defence Accounts Service on regular basis.**

The Government of India, Ministry of Defence (Finance) has approved promotion of four (04) officers serving in Junior Time Scale of the IDAS on ad hoc basis in the offices/organizations indicated against each in Annexure 'A' to this letter to the Junior Time Scale (scale of pay Rs. 15600-39100 plus Grade Pay 5400/-) of the service **on regular basis**. The competent authority has decided to retain the officers in their present offices on promotion. Accordingly, the officers may be promoted to the Junior Time Scale of the IDAS on a regular basis on the dates as indicated in the Annexure 'A' or from the date of assumption of charge, whichever is later, **provided no disciplinary/ criminal case is pending against the officers and they are not under suspension.**

The officers approved for regular promotion to the Junior Time Scale of the IDAS will be on probation for a period of two years or up to the date of superannuation whichever is earlier from the date of promotion in the first instance. Necessary assessment reports may be forwarded to this office on completion of each year of probation.

3. No TA and joining time is admissible to the officers, promotions being within same office.
