Sub-Sanction of work cases under delegated financial powers in Army/Navy/Air Force/Coast Guard/IHQ.

Ref- HQrs office I.O. No: 09 of 2015 dated 23.10.2015.

Kindly refer to this Hqrs Office above cited communication under which below Command level STS/JTS level IFAs were authorized to deal with the Authorized Works cases (AON & AE Vetting) upto Rs. 500 Lakh including Special Works upto Rs. 5 lakh, provided the same is approved in the Annual Works Plan of the Command.

- 2. The financial powers of lower CFAs in consultation with IFA to process Civil Works proposals as delegated by DFPDS-2015 have been continued under DFPDS-2016 till finalization of DWP 2007. References are being received from the executives regarding disparity in exercising of the financial concurrence powers of the IFA with regard to corresponding powers vested with the CFA viz. Corps Commander.
- 3. Earlier some of the Command IFAs were of the view that there should be some restriction in concurring power of lower IFA (i.e. (JTS/STS) as normally no Jt. IFA/Addl. IFA is posted in below the Command level IFA offices and the JTS/STS level officer may

not posssess adequate knowledge and expertise to examine works proposal. Any increase should be preceded by adequate training of lower IFAs to handle works cases.

- 4. Accordingly, during the last one year 52 Dy. IFA level IDAS officers and 161 SAOs/AOs/AAOs posted in the IFA offices have been trained on examining and processing of works cases. Further as slot on Works Cases has also been incorporated in the regular courses on "IFA Sysytem" to cater for the newly posted officers in IFA set up.
- 5. Keeping in view of the above and to enable this HQrs. to further review the financial concurrence powers authorized to below command level IFAs (JTS/STS level), in the light of provisions of DFPDS-2016, your views/comments on the issue may kindly be forwarded to this HQrs. Office by 27.01.2017 for further consideration please.
