Subject: Procurement of Vehicles

Ref : MoD (Fin) I D No 11(16)/ Bud-I/98 dated 07.05.2010 and
13.07.2011.

With reference to above cited communication, it is clarified that all proposals for procurement of vehicles including those in replacement of condemned vehicles will be referred to the MoD/ Ministry of Finance (as the case may be) to obtain sanction for type, quantity and assessed cost of vehicles being procured. On obtaining initial sanction from MoD/ Ministry of Finance, the subsequent actual procurement of vehicles will be carried out as per extant delegation of financial powers. The proposal for procurement of vehicles need not be referred to the MoD after initial sanction if the financial implication of the proposal is within financial ceiling of the delegated financial powers. Only cases beyond the financial ceiling will be referred to MoD for procurement.

2. Cases of procurement of vehicles in excess of laid down norms are required to be referred to Ministry of Finance. The other provisions contained in the referred ID Note dated 07.05.2010 will continue to apply.
3. The extant economy instructions issued by Ministry of Finance may be kept in view while initiating the proposals for purchase of vehicles.
4. This issues with the approval of Secretary (Defence Finance).
