- **2.1** The questions in both the Papers shall be objective type with multiple choice answers. The Question Booklets and Answer Sheets will be sent to the Conducting Officers in due course. The Answer Sheets shall be evaluated through OPTICAL MARK READING (OMR) Process.

- 3. Each case of intending candidates (including those who are on deputation) will be carefully examined by a Board of officers comprising JCDA/Additional CDA/CDA/PCDA, another IDAS officer and one AO/SAO. The candidature shall be recommended as per the criteria enumerated in Rule-3 and Rule-4 of the "Rules governing the examination for admission to SAS." The approved new scheme of SAS Examination has already been circulated vide this office Most Important Circular No AN/SAS/16200/Orders/Vol X dated 12.03.2007 and subsequent orders on the subject issued from time to time.
- Admission to Preliminary Test shall be open to Sr. Auditors/ Auditors/ 3.1 Clerks/Typists/DEOs/Stenographers/Hindi Translators and Librarians. To be eligible for appearing in the Preliminary Test to SAS Part-I examination, a candidate must have put two years service (including continuous temporary service) in any of these grades in the Department as on the first of the month in which the examination is held i.e. 01.04.2016 provided that the candidate must have cleared probation period. This shall be applicable to candidate's uniformly i.e. departmental candidates, or those who joined the Department through SSC or Inter-departmental transfer basis. Candidates who have qualified last Preliminary Examination (Test) held in June, 2014 but absented or withdrawn their candidatures from appearing in SAS Part-I examination held in September, 2014 will be required to re-qualify in the Preliminary Examination(Test) to be eligible to appear in SAS Part-I examination scheduled to be held in due course. There shall be no limit in appearing in Preliminary Examination. SAS Apprentices are exempted from appearing in Preliminary Examination. Candidates may choose any one optional portion viz. Army, Air Force, Navy and Factory for answering question in Part-B of Paper-2 from amongst Section-II to V irrespective of the Organization in which they are presently serving.
- 3.2 As per SAS Rule 6 and 14(b) the maximum chances for appearing in SAS Part-I and Part II examination will be only four for each part. The position has also been amplified vide para 3 (l) of HQrs. Office Most Important Circular No. AN/ SAS/16200/0rders/Vol.X dated 12.03.2007. Additional chances may, however, be permitted by the CGDA as per merit of each case. Accordingly, a candidate who has availed four maximum chances for SAS Part-I examination after qualifying Preliminary Examination(Test) held in June 2007 and September 2008, are not eligible to appear again in Preliminary Examination(Test), April 2016 for getting further chances.
- It is re-iterated that only those candidates who have failed to qualify the Preliminary Examinations (Test) held in past i.e. June 2007, Sept 2008, Aug 2012 and June 2014 except the condition elucidated at para 3.1 above or not appeared in above Preliminary Examination (Test) so far would be eligible to appear. In case of disclosure of any wrong/incorrect information regarding eligibility criteria of an individual on later stage, the individual will be disqualified from the examination and benefit if any awarded consequent on passing of the examination would be taken back without assigning any further reason and without prejudice to such further action as may be taken under the provisions of the law for giving false information. An undertaking in this regard may be obtained and kept on record.
- **4.** Names of intending candidates who fulfill the above criteria and are recommended by the Board of Officers, may please be sent to Hqrs. Office (both hard copy as well as CD in MS Excel) in the enclosed proforma.

- **5.** Following instructions may be observed while completing the above proforma:-
 - (a) The Centre of examination will be the nearest to the duty point of the candidate. In case where due to exceptional circumstances, a candidate desires to take examination at a Centre other that the one nearest to his/her duty point, his/her application together with specific recommendation of the Principal Controller/ Controller, should be forwarded to this office for consideration.
 - (b) The examination will be conducted at Allahabad, Bangalore, Chandigarh, Cochin, Chennai, Dehradun, Guwahati, Jaipur, Jammu, Jabalpur, Kanpur, Kolkata, Lucknow, Meerut, Mumbai, New Delhi, Patna, Port Blair, Pune-A' {PCDA(O)}, Secunderabad provided sufficient candidates are appearing there from. The Centres are subject to change depending on administrative convenience. The candidates should be advised to give firm indication of the Centre (with due regard to the prescribed criteria) in the very first instance. The instructions contained in this Office Memo No.33012/(5)N 1/AN/-K dated 30.10.71 in regard to freezing of transfer of candidates after notification of Roll Number may also be adhered to as far as possible.
- **6.** Further in pursuance of guidelines notified vide Ministry of Social Justice and Empowerment, Deptt of Disability Affairs, New Delhi OM No 16-110/2003-DD.III dated 26.02.2013 details of the physically handicapped category of the candidates may be intimated. In case a physically handicapped candidate is desirous of facility of scribe/compensation time etc, application duly recommended by PCDA/CDA along with requisite medical certificate may be forwarded for consideration of request by the Competent Authority.
- 7. In accordance with the instructions contained in Govt. of India, Deptt. Of Personnel & Administrative reforms OM No 36021/10/76-Estt (SCT) dated 21.01.1977 regarding relaxation in qualifying standard for SC/ST candidates in qualifying examination, it has been decided by CGDA to lower/relax the qualifying standards for SC/ST candidates appearing in this Examination upto a maximum extent of 5% in individual paper/aggregate. This may be brought to the notice of all the SC/ST candidates.
- **8.** Names of candidates who belong to reserved community may please be furnished to this office while sponsoring their names itself, as per instructions contained in this office Circular No. 0611/AN/K/(Orders) dated 12.09.77. The list of SC/ST candidates may please be prepared independently after verifying the service-books of all the candidates and not on the basis of information furnished by the candidates concerned. It may also be certified as, "The list furnished to HQrs office has been prepared with reference to the information recorded in the service-book of the candidates concerned".
- **8.1** Candidates may also be asked to declare whether they belong to the reserved or the unreserved community as on date of this notification and such declaration may be kept on record. A specimen of the declaration is enclosed. Further, in pursuance of HQrs Office Circular No.AN/II/2151/PC-1089(N) dated 11.01.2012 regarding verification of caste certificate of SC/ST & OBC candidates at the time of initial appointment/promotion, it is requested that necessary undertaking as stipulated therein, in consonance with DoP&T OM No. 36011/3/2005-Estt(Res), dated 09.09.2005 may also be invariably obtained from SC/ST candidates besides aforesaid declaration and kept on record.

Principal Controllers/Controllers are requested to obtain in writing from the intending candidates that they will not apply for withdrawal of their candidature from the above examination on the plea of sickness of family, domestic affairs or non-availability of books etc. It may be impressed upon the candidates that it is in their own interest to take the Preliminary Test seriously and secure qualifying marks to be eligible for appearing next SAS Part-I Examination scheduled to be held in due course.
