Redefining the roles and responsibilities of Focal Point Branches (FPBs) - Constitution of a working Group

As you are aware that the captioned issue was discussed in detail during the 7th High level Meeting on Government Banking held on April 16, 2018 at New Delhi. It was suggested in the meeting that a Working Group be formed to look into various issues related to the operations and role of FPBs.

- 2. Accordingly, it has been decided to constitute a Working Group to look into the role and responsibilities of FPBs in the light of the present electronic environment. It has also been decided that senior officials from the Office of Controller General of Accounts, Office of Comptroller and Auditor General of Accounts, Department of Telecommunications, Department of Posts, Office of Controller General of Defence Accounts, Indian Banks' Association, State Bank of India, Bank of Baroda, Bank of India will be part of the Working Group.
- 3. The Group will be headed by Smt. Charulatha S. Kar, Chief General Manager, Department of Government and Bank Accounts, Reserve Bank of India. The undersigned will act as Member Secretary of the Group. The Terms of Reference of the Group is enclosed.

4. You are requested to kindly nominate a senior officer from your Office, who is conversant with the subject, to participate in the Group for finalization of its recommendations. An early communication in this regard will enable the Group to be formulated and fulfil the action point emanating from the 7th HLM.

Terms of Reference of the Group

- (i) To assess the current role of FPBs in the context of the government banking business (both Central and State Government;
- (ii) To evaluate the authorisation process of the FPBs;
- (iii) To evaluate the role of FPBs vis-à-vis link offices of the banks at Nagpur (for Central Government transactions);
- (iv) To assess the functioning of FPBs in the context of increasing digitalisation of government banking business;
- (v) To recommend, based on the above assessment, the role of FPBs in future;
- (vi) Any other item with the approval of the Chair.
