Please refer to this office letters of even No. dated 18/11/2014 and 02/02/2015 wherein it had been intimated that Ministry of Defence (Finance) desired to place a system of liaison officers in all the PCsDA/CsDA to ensure speedy and authenticated flow of allocation letters to come into effect in quarter 4 of Previous Year 2014-15 along with the RE.

- 2. Accordingly, the guidelines for liaison officers, duly approved by the FA(DS), alongwith lists of liaison officers were forwarded by this office vide letter dated 02/02/2015.
- 3. The ibid guidelines were to be implemented for the capital budget for the present and report on the functioning of this system was required to be submitted to this office at the end of the financial year by 30th April 2015 for onward submission to Ministry of Defence (Finance). However, the same has not yet been received. It is, therefore, requested that comments of your office on the implementation of this system may please be sent to this office at the earliest.
- 4. Attention is also invited to para 5 of this office letter of even No. dated 2nd February 2015, wherein it was intimated that Ministry of Defence (Finance) also desired that steps may also be taken to devise a mechanism for Centrally Controlled heads under the Revenue budget as mentioned in the guidelines. For illustration, MGO's Branch is making sub-allocation under the Ordnance Stores (Revenue) to CODs and concerned PCsDA/CsDA which is centrally controlled and monitored by the IHQrs of MoD (Army) Hence, Controller offices are required to intimate position/progress under this and such other revenue heads. An action taken report in this regard may also please be submitted to this office at the earliest.
