Subject: Dispatch of PM Data on Weekly Basis.

The schedule for dispatch of weekly data for the months of January 2012 to March 2012 is enclosed herewith. - (2) Effort should be made to include all PM data by third week to minimize the load on the last week. Arrangement may be made to collect the PMs on daily basis locally in the last week.
- (3) The dates for closing of accounts for the year 2011 2012 (for March 2012 (03/2012), March Supple 2012 (13/2012) and March Supple Correction 2012 (14/2012)) will be intimated later.
- (4) It may please be noted that in the last week, weekly data may also be sent in addition to monthly data.

(5) Instances have come to the notice in which certain Controllers have rendered data files after due dates, which disturbed our commitment to render monthly figures to the Ministry. It is therefore requested that dates for rendering data files to the HQrs. Office are strictly followed.
