Kindly refer to MHA Office Memorandum No. D.I-6/2017-Pers.DA-I dated 04/03/2022, MHA D.O. dated 29/03/2022 and this Directorate letter of even number dated 29/03/2022 on the captioned subject (*copies enclosed for ready reference*).


2. It is intimated that 03 posts of Deputy Financial Advisor (DFA) in PB-3 with Grade Pay of Rs. 7,600/ (pre-revised) (Level 12 in the Pay Matrix – revised) in CRPF are lying vacant. These posts are located @ one each at Zonal Hqrs, Jammu, Kolkata, and Guwahati. As per Recruitment Rules, these posts are to be filled up by deputation of officers of the Central Government belonging to any of the Organized Accounts Services and the post of Deputy Financial Advisor carries scale of pay in Level-12 (Rs.78,800-2,09,200) in Pay Matrix. The officers holding analogous posts in the pre-revised pay scale of Rs.15,600-39,100 + GP Rs. 6,600 in PB-3 (revised Pay Matrix Level-11) are eligible for the post of Deputy Financial Advisor in CRPF on deputation basis. The period of deputation is 04 years.

3. Therefore, requests were made Office Memorandum, D.O. and letters under reference to sponsor nominations of eligible and willing officers having work experience in Central Civil Ministries, from your Organization, to fill up the vacant posts of Deputy Financial Advisor in CRPF on deputation basis. However, required nomination has not been received so far.

4. I am, therefore, directed to request you again to kindly look into the matter and arrange to forward sufficient nomination of eligible and willing officers (mentioning therein their choice for place of posting) along with their CR dossiers and allied documents to this Directorate at the earliest to assess their suitability for induction in CRPF on deputation basis please.
