S.R.O.------ In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Defence Accounts Department (Auditor) Recruitment Rules, 2022, namely:-

- 1. (1) These rules may be called the Defence Accounts Department, (Auditor) Amendment Recruitment Rules, 2023.
 - (2) They shall be deemed to have come into force on the date of publication in the Official Gazette.
- 2. In the Defence Accounts Department, (Auditor) Recruitment Rules, 2023 in the Schedule, the column 10(iii) may be amended as:-

For

"10% by promotion from amongst Graduate clerks-cum-Typists and Graduate Multi-Tasking Staff on passing the departmental examination."

Read

"10% by promotion from amongst Graduate clerks-cum-Typists on passing the departmental examination."

And column 11 (ii) may be amended as:-

For

" 10% by promotion from amongst Graduate Clerks-cum-Typists and Graduate Multi-Tasking Staff having a minimum of three years of service on passing the Departmental Examination by them for the post of Auditor."

Read

"10% by promotion from amongst Graduate Clerks-cum-Typists having a minimum of three years of service in the clerk-cum-typist cadre who have been confirmed in the post held, on passing the Departmental Examination by them for the post of Auditor."
