

रक्षा लेखा विभाग में विरष्ठ अनुवाद अधिकारी (वेतन मैट्रिक्स में स्तर 7) तथा किनष्ठ अनुवाद अधिकारी (वेतन मैट्रिक्स में स्तर 6) के पदों के भर्ती नियमों में संशोधन का मामला विचाराधीन है। प्रस्तावित भर्ती नियम, जिसमें मसौदा संशोधन तथा अनुसूची शामिल हैं, कार्मिक एवं प्रशिक्षण विभाग द्वारा जारी अनुदेशों के अनुसार तैयार किए गए हैं।

Defence Accounts Department proposes to amend Recruitment Rules (RRs) for the posts of Senior Translation Officer (Level 7 in pay matrix) and Junior Translation Officer (Level 6 in pay matrix). The proposed RRs containing draft Amendment and Schedule have been framed in accordance with instructions issued by the Department of Personnel and Training (DOP&T).

# Notification

# 1. Short title and commencement.—

- (1) These rules may be called the Defence Accounts Department, Senior Translation Officer and Junior Translation Officer (Group 'B' posts) Recruitment Rules, 2020.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. **Application.** These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.
- 3. Number of posts, classification, pay band and grade pay or pay scale. —

  The number of the said posts, their classification and the pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the said Schedule.
- 4. Controlling authority.—

The said posts shall be administratively controlled by the Controller General of Defence Accounts under the Ministry of Defence (Finance Division).

5. Method of recruitment, age-limit, qualifications, etc.—

The method of recruitment, age-limit, qualifications and other matters relating to the said posts shall be as specified in columns (5) to (13) of the said Schedule.

6. Liability of service.—

Any person appointed to the said posts under these rules shall be liable to serve anywhere in India.

- 7. **Disqualifications.** No person,
  - (a) who has entered into or contracted a marriage with a person having a spouse living, or
  - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 8. Power to relax. Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 9. Saving. Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Schedules Castes, the Scheduled Tribes, Other Backward Classes, Ex-servicemen and any other special categories of persons in accordance with orders issued by the Government from time to time in this regard.
