Subject: Promotion of Clerk to the grade of Auditor for the vacancy period 01.04.2018 to 31.12.2018 being transition year.

Reference is invited to the provisions contained in DOP&T O.M bearing No.22011/4/2013-Estt. (D) dated 08.05.2017 according to which certain changes may be affected in the DPC Procedure in partial modification of DOP&T O.M No.22011/5/86-Estt (D) dated 10.04.1989 ,O.M No. 22011/9/98-Estt (D) dated 16.06.2000 ,OM No. 22011/9/98-Estt.(D) dated 08.09.1998 and Om No.22011/6/2013-Estt(D) dated 28.05.2014 (Crucial date of eligibility). Accordingly it is requested to convene a DPC as per Annexure `A' to adjudicate those clerk-cumtypist who are holding the feeder post of clerk-cum-typists on regular basis as on the 26<sup>th</sup> day of September 2009 and completing eight years of qualifying service in the grade on 01/04/2018 for the promotion to the grade of Auditor on the basis of their APARs for the years 2015-16 , 2014-15,2013-14,2012-13, and 2011-12 as per Recruitment Rules for the Post of Auditor as amended vide SRO No. 23 dated 03/05/2016. While considering the APARs the provisions contained in DOP&T OMs on the subject may also be kept in view.

- 2. As per SRO No. 23 dated 03/05/2016, para 1 of column 12, for 40% of promotion from amongst clerk-cum-typists to the post of Auditor , the minimum service criteria have been increased to 13 years from eight years, as such all such leftover cases may also be considered while adjudicating the case. It may be ensured that no cases have been left over.
- 3. DPC Proceeding along with adjudication report of the eligible clerks in the Performa enclosed with this letter may kindly be sent to reach this HQrs office latest by 31/01/2018. It may also be ensured that no eligible individual falling within the zone of consideration has been left for adjudication.
