A copy of MoD D(Mov) ID dated 21.03.2018 cited under reference on the subject is forwarded herewith.

2. Under the ibid communication, MoD has opined that distance according to railway map cannot be deemed applicable due to the fact that the distance of rail alignment may be increased/decreased due to various factors on the way. Further, distance depicted on Google Maps cannot be treated as authentic, it being a private entity.

Further, MoD has stated that the road distance as mentioned in any Government publication (e.g. Indian Road Distance guide) may be treated as applicable for calculation of road distance.

3. Hence, all PCsDA/CsDA may take necessary action as per MoD guidelines stated above

Subject: Variation of road distance in permanent transfer claims.

Reference CGDA's Communication No. AT/IV/4462/Road Distance dated 14th July 2017 on the subject cited above.

2. In this regard it is stated that the road distance as mentioned in any Government publication (Indian Road Distance Guide in the instant case) may be treated as applicable. It is further opined that distance according to railway map cannot be deemed applicable due to the fact that distance of rail alignment may be increased/decreased due to various factors on the way. Further, the distance depicted on Google Maps cannot be treated as authentic due to being a private entity and generally it shows more than one way to the destinations and therefore, it states variance in its own map.
