As you are aware that to strengthen resolution of commercial disputes as well as to boost institutional arbitration in the country, the Parliament has amended the Arbitration and Conciliation Act, 1996 in 2015 and again in 2019. Further, New Delhi International Arbitration Centre Act, 2019 has also been passed.

- 2.
