IFA. The promotion of officer shall be effective from date of the assumption of charge of the new post, provided no disciplinary/criminal case is pending against the officer and he is not under suspension (Para 2 and 7 of DoP&T OM No. 22011/4/91-Estt.(A) dated 14.09.1992 and Para 8 of DoP&T OM No. 22034/4/2012-Estt. D dated 02.11.2012).

- 2. Further, it is also stipulated that in pursuance of DoP&T OM No. 36012/11/2016-Estt.(Res-I) (Pt. II) dated 15.06.2018, the above promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court on account of interim orders/directions in Special Leave to Appeal (C.) No. 30621/2011 (Jarnail Singh & Ors Vs Lachhmi Narain Gupta & Ors.) arising out of final judgment and order dated 15/07/2011 in CWP No. 13218/2009 passed by the Hon'ble High Court of Punjab & Haryana and Special Leave to Appeal (c) No. 31288/2017 arising out of Hon'ble Delhi High Court judgment dated 23/08/2017 and Hon'ble Supreme Court order dated 27/11/2017 in SLP (C) No. 17491/2017 (UOI & Ors v/s Sanjeev Malhotra & Ors) and Hon'ble High Court of Punjab & Haryana at Chandigarh order dated 06/02/2017 in CWP No. 24671 of 2016 (Union of India & Ors v/s Shaneel Rana & Others) and other related court cases.
- 3. The officer may also be requested that on reporting in the new office of posting, he may inform his date of joining, correspondence address, telephone Nos. (Official,

- 4. The relief of the officer shall not be deferred on the ground that a representation has been submitted for change of place of posting or on the ground that reliever has not reported/been posted. It may be brought to the notice of the officer that no representation for change of posting etc. will be entertained in any case, as the IDAS carries a definite liability to serve anywhere in India including field service in or out of India. The Pr. Controller/Controller may also ensure that representations are not unduly forwarded.
