Subject: Review DPC for the promotion of Asstt. Accounts Officers to Accounts Officer's grade against the vacancy year 2015-16.

Consequent upon revision of Seniority Roster of AAOs published vide HQrs office No. AN/XI/11071/Roster/AAO/2014 dated 08.04.2016 with retrospective effect 31.03.2014, a Review DPC was constituted as per the provisions contained in para 18.1(a) to (c) of G.I., DoP&T O.M. No. 22011/5/86-Estt. (D), dated 10th April, 1989 as amended by O.M. No. 22011/5/91-Estt.(D), dated 27th March, 1997 to provide a Revised Select Panel of AAOs for promotion to the grade of Accounts Officer against the vacancy year 2015-16.

2. The aforesaid Review DPC 2015-16 provided a Revised Select Panel of AAOs for promotion to the grade of Accounts Officer against the vacancy year 2015-16. As per the Revised Select Panel, the position/seniority of some of the AAOs has undergone change as compared to their inter se seniority in the Select Panel provided by the Original DPC 2015-16. Accordingly, the following amendments/changes are being made in the promotion orders of AAOs to AO's grade issued earlier by the HQrs Office vide No. AN/II/2151/DPC/ AAO to AO /2015-16/3 dated 27.11.2015 & No. AN/II/2151/DPC/AAO to AO/2015-16/4 dated 15.03.2016 :-

- (i) 14 (Fourteen) Officers listed in Annexure- "I" to this letter, who were promoted from AAO to AO's grade (Sl. No. 01 to 07 promoted vide No. AN/II/2151/DPC/ AAO to AO /2015-16/3 dated 27.11.2015 & Sl.
