Subject: - Revision of Seniority in SAG: - IDAS Officers

In compliance to the order of the Hon'ble Tribunal dated 18/08/2017 in OA No. 3345/2015 filed by Smt. Rasika Chaube which was upheld by the Hon'ble High Court of Delhi vide its order dated 05/11/2019 in WP (C) No. 9694/2017 filed by UoI seniority in JAG was revised vide this office letter of even no. dated 28.07.2020. Consequently, a Review DPC for the vacancy year 2005-06 for promotion to SAG of the IDAS was convened on 08/01/2021.

- 4. The said Review DPC after examining all the relative facts, recommended the name of Smt. Rasika Chaube for promotion to the Senior Administrative Grade of the IDAS against the vacancy year 2005-06 at S No. 2-A above Sh. Sanjeev Kumar, (S No. 3) and below Sh. R K Choudhary (S No. 2). Accordingly, her name stands recommended at S No. 9A in the consolidated panel in place of S No. 2 in the extended panel on the consolidated panel as had been recommended by the original DPC held on 22/03/2006.
- 5. Accordingly, the Appointments Committee of the Cabinet has also approved the empanelment of Smt. Rasika Chaube for promotion to the Senior Administrative Grade (SAG) of the IDAS w.e.f. 22.05.2006 i.e. at Sl. No. 9-A above Shri Sanjeev Kumar at Sl. No.10 and below Shri R K Choudhary at Sl. No. 9, in the consolidated panel for the panel year 2005-06. This would not have any monetary implications and would only result in the revision of inter se seniority of Smt. Rasika Chaube as her junior has also been promoted to SAG of the IDAS.
- 6. Accordingly, the seniority list (panel position) of all the officers assessed in the original DPC dated 22.03.2006 in SAG is revised as under:-
