Subject: Regarding conducting of Swachhata Hi Seva (SHS) 2023 as part of 'Swachhata Pakhwada'.

The Ministry of Housing and Urban Affairs, New Delhi have conveyed that a massive cleanliness drive is envisaged to be held on 1st October, 2023 at 10.00 am across the country as a tribute to Mahatma Gandhi on the eve of his birth anniversary on 2nd October, 2023.

- 2. Accordingly, the DAD has identified various activities across all Controllers' Offices which have to be taken up in this cleanliness drive as part of 'Swachhata Pakhwada', and have been conveyed to the Ministry of Defence as part of the activities to be undertaken by the department.
- The Competent Authority has, therefore, directed that following activities will be taken up by the Field Controllers on the occasion of cleanliness drive on 1st October, 2023 from 10.00 am to 11.00 am as per following details:
 - i) From 25th to 30th September, 2023:- All Controller offices of DAD will carry out weeding of old files, dismantled material and building rubbish lying in common areas and ensure clean surroundings repair and maintenance of office buildings. All staff and officers to be engaged necessarily in this activity.
 - Main event 1st October, 2023 'Ek Tarikh Ek Ghanta':- Shramdaan, ii) plantation of trees, all parks of residential area will be cleaned for proper up keep and maintenance. All staff and officers and family members to be engaged in these activities.
 - iii) 2nd October, 2023 offering Shradhanjali, felicitation etc.
- All Controller offices are requested to please take note of details of activities as given in para (3) above and mobilize staff members as well as family members for successfully holding 'Swachhata Hi Seva' campaign. All out efforts may be made to ensure that activities as approved above are conducted across DAD offices as well as in residential areas ensuring proper cleaning of surroundings by offering shramdaan on this occasion.
- It is also requested that a report on the activities taken up along with videos and photographs may be compiled and rendered to the HQrs office by 4th October, 2023. It is also requested that Controllers' Offices or any officer or member or staff will not

issue any report/picture/video on electronic as well as in print media or post these activities on any of the social media platforms. Propagation of activities through pictures and videos will be done by MoD through CGDA in accordance with directions issued by Ministry of Housing & Urban Affairs, restricting such propagation by Central Ministries only.
