Consequently, the officers working in the Department may be designated as Sr. Dy. CGDA/Addl. CDA/Addl. IFA as the case may be, with effect from the same date. The placement in the above grade in respect of officer(s) who are presently on deputation, will be treated as proforma placement.

4. It may please be ensured before placement of the officer(s) as stated above, that none of the circumstances enumerated in Para 2 of the DoPT OM No. 22011/4/91-Estt.(A) dated 14.09.1992 & DoPT OM No. 22034/4/2012-Estt(D) dated 02.11.2012 have arisen.


